Limited Eligibility

The following individuals are **NOT** eligible:

- Students with **F1 Visas** on their first year but can apply in subsequent years.
- Students with **J1 Visas**.
- Students enrolled in the professional programs of veterinary medicine and law.
- Students enrolled at Texas A&M University Galveston, Texas A&M University Qatar, and the Texas A&M Health Science Center (Medicine, Dentistry, Pharmacy, Public Health, Nursing)

The following individuals **ARE** eligible

- Mexican nationals that will be applying for the **Mexican Citizens with Financial Need Waiver** are eligible with an F1 or J1 visa.
- International undergraduate and graduate students seeking degrees from the **College Station campus**.

INDEPENDENT students submit the following:

- Student/Spouse 2021 signed tax return OR tax transcript from Internal Revenue Service (IRS)
- 2021 W-2's for ALL wages
- 2021 1098/1098T (if applicable) for all other earnings (for example fellowships.)

*If you and/or spouse did not work in the U.S. in 2021, however you or your spouse did work in another country, you must submit official documentation from your employer indicating the income earned and taxes paid.
